Discount Eligibility

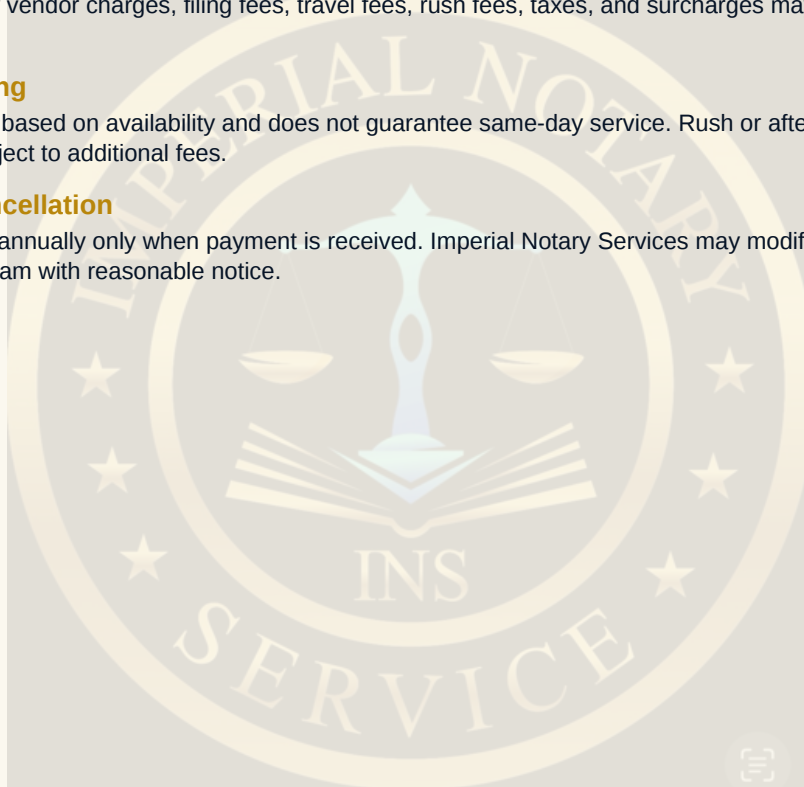
